An Act to amend certain Writt	ten Laws

ENACTED by the Parliament of the United Republic of Tanzania.

- 1. This Act may be cited as the Written Laws (Miscellaneous Amend- Short title ments) Act, 1977.
- 2. The laws specified in the first and second columns of the Schedule Amendment hereto are amended in the manner specified opposite thereto in the certain third column.
- 3.—(1) It is hereby declared that the National Standards Institute Effect of established by the Standards Act, 1975 shall, as from and after the to the commencement of this Act, by virtue of the amendments to that Act Standards effected by this Act, be known as the Tanzania Bureau of Standards, Act, 1975 and the Standards Act, 1975 shall be read and construed accordingly, No. 5
- (2) Wherever in any other written law or in any public or other document reference is made to the National Standards Institute that reference shall be read and construed as a reference to the Tanzania Bureau of Standards.
- (3) The change of name provided for in this Act shall not affect anything previously done by the National Standards Institute, and the validity of any act shall not be called in question solely by reason of the use of the name Tanzania Bureau of Standards instead of the name National Standards Institute.

Acts, 1973, No. 12

The Acquisition of Shares (Aluminium Section 9 is amended— Africa Company Limited) Act, 1973.

- (a) in suit-paragraph (ii) of paragraph (c) by deleting the word "three" which occurs in the second line and substituting therefor the word "four";
- (b) by adding immediately below sub-paragraph (ii) of paragraph (c) the following new sub-paragraph: -
 - "(iii) not more than three other directors appointed by the directors specified in sub-paragraphs (i) and (ii)";
- (c) in paragraph (d) by deleting the words "three directors to be appointed by the other shareholders" which occur in the fourth and fifth lines and substituting therefor the words "four directors to be appointed by the other shareholders and to the three directors to be appointed under sub-paragraph (iii) of paragraph (c)".

Acts, 1974, No. 26

The Audio-Visual Institute of Dar es Salaam Act, 1974.

The Act is amended by adding immediately below section 4 the following new section: -

"Delivery to films made Tanganyika T

4A.—(1) Every person, other than the Institute, who produces or causes to be produced in Tanganyika any film intended for sale or public F.lm Library distribution or exhibition, whether for a fee or other valuable consideration or without a fee or other valuable consideration, shall, within thirty days after the day on which the production of the film is completed and notwithstanding any agreement in respect of the production of the film, deliver at his own expense two copies of the film to the Governing Board:

> Provided that the Governing Board may direct, either in relation to any particular film or class of films or in relation to any particular person or category of persons, that the person producing the film shall deliver one copy only:

> Provided further that the Minister may, if he considers it to be in the public interest to do so, by writing under his hand exempt any person from the requirement of this subsection.

- (2) The Governing Board shall deliver every copy of a film delivered to it under this section to the National Film Library referred to in section 4 (c).
- (3) Every copy of a film delivered under this section shall be a copy of the whole film finished in the same manner and made of the same material as the best copies of the film are produced.

(4) Any person who fails to comply with the provisions of subsection (1) or of subsection (3) shall be guilty of an offence and shall be liable upon conviction to a fine not exceeding twenty thousand shillings or to imprisonment for a term not exceeding three years or to both such fine and imprisonment, and the court before which the offender is convicted may in addition order him to deliver to the Governing Board a copy of the film in respect of which the conviction is recorded".

Acts, 1975. No. 3 The Standards Act, 1975.

The Act is amended—

- (a) in the long title by deleting the words "a National Standards Institute" and substituting therefor the words "the Tanzania Bureau of Standards"; and
 - (b) in the Act generally by deleting the words "Institute", "the Institute" and "the National Standards Institute" wherever they occur and substituting therefor respectively the words "Bureau", "the Bureau" and "the Tanzania Bureau of Standards", as appropriate, in each case.

Acts, 1975 No. 6 The Tanzania Library Services Board Section 5 of the Act is amended in subsection (2)—Act, 1975.

- (a) by inserting in the third line immediately after the words "literary work" the passage "(other than a film)"; and
- (b) by deleting in the first line of the proviso the comma which occurs immediately after the word "record", and deleting in the same line the word "film".
